In consideration for taking kiteboarding lessons, riding on boat/jet ski, using OBK kiteboarding equipment, launching from boat and property, using facilities associated with OBK, engaging in the sport of kiteboarding, land instruction, water instruction and related activities, I hereby understand and agree to this release of liability, waive of legal rights, and assumption of risk, and to the terms hereof as follows, and understand that OBK does not issue refunds, only credits:

- 1) I acknowledge that kiteboarding is an action sport and recreational activity involving travel in three dimensions and such activity is subject to mishap and even injury to participants. I understand I may suffer a broken limb, paralysis, or fatal injury while participating in the sport of kiteboarding.

- 2) I hereby RELEASE AND DISCHARGE OBK, the state of North Carolina, owners of OBK and employees (herein referred to as "released parties"), from any and all liability, claims, demands, or causes of action that I may hereafter have for injuries, disability, or death, or damages arising out of my participation in kiteboarding activities, including, but not limited to, losses CAUSED BY THE NEGLIGENCE OF THE RELEASED PARTIES.

- 3) I understand and acknowledge that kiteboarding activities have inherent dangers that no amount of care, caution, instruction, or expertise can totally eliminate. I EXPRESSLY AND VOLUNTARILY ASSUME ALL RISK OF DEATH OR PERSONAL INJURY SUSTAINED WHILE PARTICIPATING IN KITEBOARDING ACTIVITIES WHETHER OR NOT CAUSED BY THE NEGLIGENCE OF THE RELEASED PARTIES.

- 4) I further agree that I WILL NOT SUE OR MAKE A CLAIM against the released parties or other losses sustained as a result of my participation in kiteboarding activities.
